- c. L. Kahihikolo inquired about whether the minutes are meant to be verbatim or rather meant to capture the intent. K. Pien clarified it was the latter. Moving forward, future minutes will be edited and commented on accordingly.

- RAB Charter
  - a. K. Pien passed around the approved RAB charter including the latest L. Kahihikolo edits for ratification

### IV. Project Fieldwork Status Update

- Greg Jacobs, Senior UXO Supervisor, Huikala LLC.
  - a. Nothing found to date at Olomana or the Royal Hawaiian Golf Club
  - b. 54% survey completed, 30% sweep completed
  - c. The first MEC item was discovered today
    1. Partial 75-mm shrapnel round- only back half which contains black powder
      - a. Able to move.
      - b. Under guard
      - c. Notifications and coordination taking place
  - d. Munitions debris: 37-mm practice, 60-mm practice, fuze pieces, frag.
  - e. 38 pounds of non-munitions debris
  - f. 22 archaeological features to date
    1. None impacted
  - g. Many of the proposed parallel transects are inaccessible
    1. Meandering transects are being substituted
  - h. Pictures of the fieldwork, blessing ceremony and MD items were shown
  - i. C. Burrows inquired about firing points
    1. G. Jacobs responded that limited historical documentation and physical evidence including types of munitions used will inform where likely firing points were located

2. Historical documentation is included in the Inventory Project Report available in the repositories (public libraries) and the website
- j. L. Kahihikolo inquired about schedule
1. G. Jacobs responded that September 24<sup>th</sup> is the scheduled transect completion date to be followed by grid placement
- David Shideler, Principal Investigator/Historian/Oahu Office Director, Cultural Surveys Hawaii
    - a. 22 new archaeological sites/historic properties located to date
      1. Somewhat lower than expected possibly due to the high elevation of investigation area
      2. One of the features identified was an activity area- roughly discoidal shape, 2 meters in diameter
        - a. Abrasion surfaces readily apparent
        - b. Consistent with the grinding and reduction of lithic tools
        - c. Clearly pre-contact
      3. A number of mounds and terraces- agricultural and habitation
        - a. Many post-contact
      4. A number of water diversion structures for water management from a spectrum of time periods, probably used, maintained, and updated continuously
        - a. Diversion dam
