Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The remnant Aweoweo Stream located on the requestor's parcel possesses no discernable bed and bank, nor does it support an ordinary high water mark. This non-tidal drainage ditch has undergone substantial anthropogenic modifications (e.g., grading and excavation) such that the feature now functions as a retention basin that collects irrigation and stormwater run-off from upstream areas, including Dole Plantation. This feature supports an accumulation of sediments and non-hydrophytic vegetation. Surface flows and rainfall that are retained during heavy rain events evaporate and/or infiltrate into the ground, but do not flow into the Pacific Ocean. Per the 1986 Preamble (51 FR 41206) we do not consider this non-tidal drainage feature to be jurisdictional and per 33 CFR 328 we do not find this feature to meet the definition of a waters of the U.S. Therefore, this feature is not regulated under Section 404 of the CWA.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
