C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

According to a letter from the applicant dated 9 September 2015, it appears there is no flow within the crossing except after rainfall events. However, Due to the presence of debris buildup, matted vegetation, sediment sorting, sediment washed from roots on the left bank of the stream, and the relatively high amount of rain this area receives during the rainy season each year, it appears the tributary has

seasonal flow. "The Atlas of Hawaiian Watersheds and their Aquatic Resources," by the Division of Aquatic Resources, Department of Land and Natural Resources, State of Hawaii, April 2008, lists this stream as Perennial. Field observations on 14 October 2015, indicate sediment sorting, exposed tree roots on left bank of stream, matted down vegetation, and debris build up on trees on left bank. According to <http://www.prh.noaa.gov/>; 28 October 2015, this area receives 170 inches average annual rainfall.

These observations indicate the presence of the Ordinary High Water Mark (OHWM) and support the presence of seasonal flow.
