C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Honolulu District, U.S. Army Corps of Engineers Guam Regulatory Field Office reviewed all of the information (see file) provided by the Guam Department of Public Works for a determination that the parcel for the proposed new building for Foster Care Children (Tract 9, Lot#14, Block F, Parcel M04-T9-BF-L14) in Barrigada Heights, Barrigada, Guam did not contain any jurisdictional waters of the U.S, including wetlands.

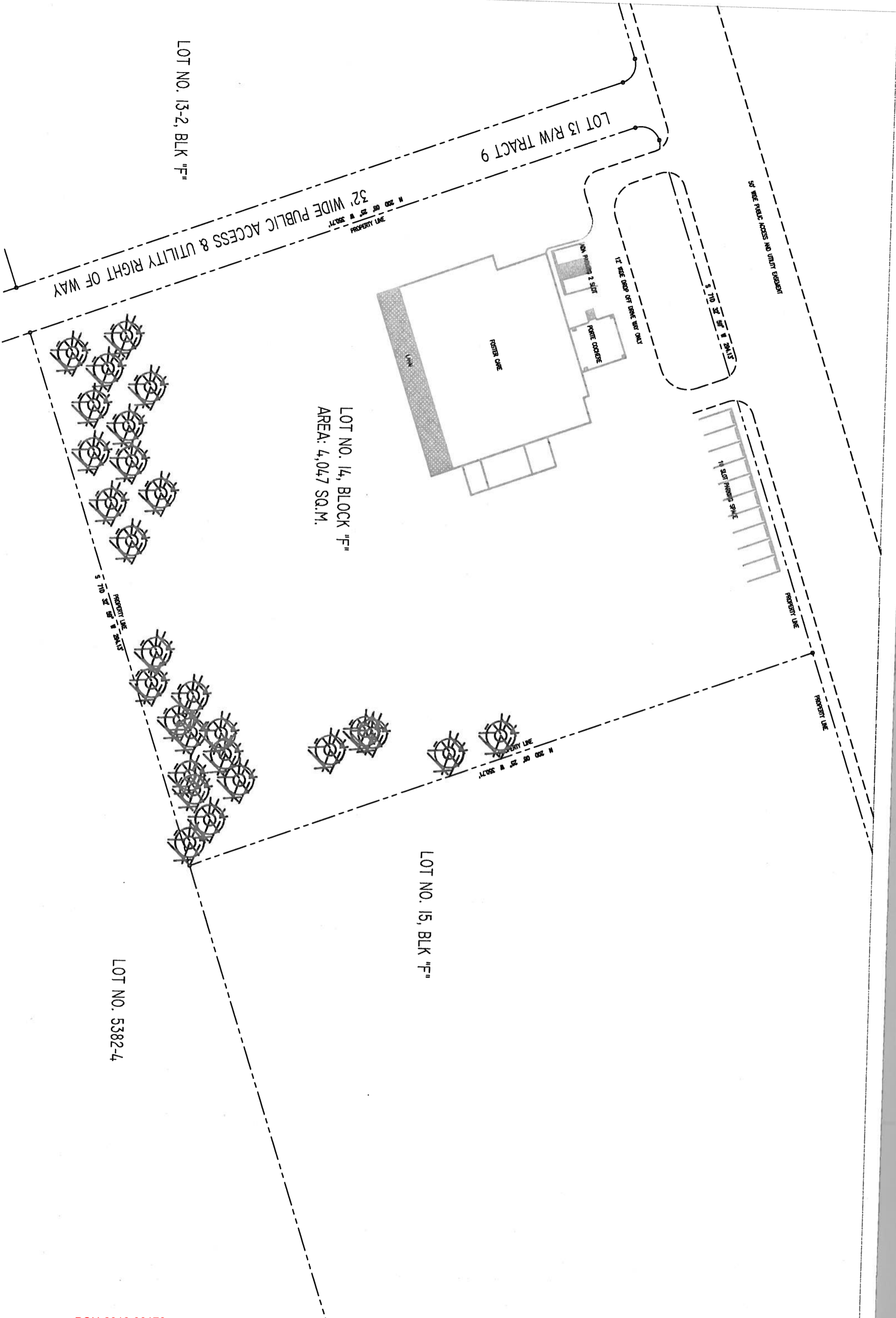
The Wetland Delineation Report dated August 15, 2016, neighboring residents state that the Lot has been cleared historically for pig production and the vegetation has been consistently disturbed. Additionally, there are a couple areas on the Lot in which limestone gravel has been placed in cleared areas were seen. During a site evaluation by Guam Department of Agriculture in June and August 2016, it was noted that the vegetation was dominated by Tangan tangan (*Leucaena leucocephala*) (UPL) and other FAC-UPL plant species and non- native ornamental plants were common along the perimeter of the property. Pago can be an indicator of wetland habitat but there was no area surveyed in which Pago was the majority plant. According to the Guam Soil survey, the soil in this plot of land is classified as Guam cobbly clay loam, in which hydric inclusions are improbable. This soil type is defined as "very shallow, well-drained soil found on limestone plateaus" The soil on the property is primarily limestone with a thin layer of soil. There were no indicators of hydrology. There were signs of hydrology along the side of the road bordering the property, primarily plant material deposited against the bases of weeds growing along-side the road, but no signs of hydrology were seen in the property.

Upon review of the Wetland Delineation Report dated August 15, 2016, revised datasheets dated August 18, 2016, soil surveys, National Wetlands Inventory (NWI), and the National Hydrography Dataset (NHD), the Corps has concluded that the subject parcel does not contain jurisdictional waters of the U.S, including wetlands.

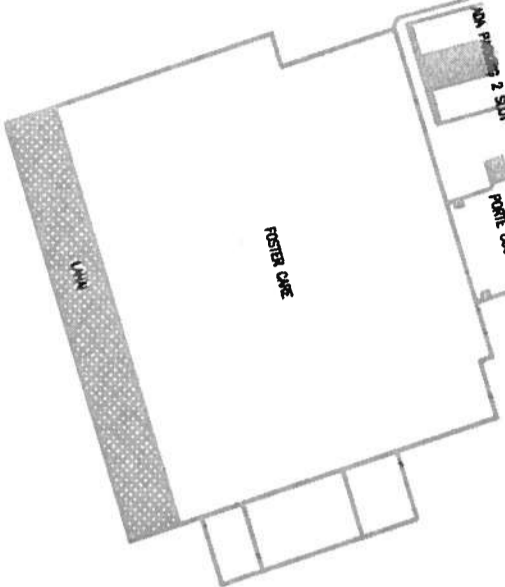


LOT NO. 13-2, BLK "F"

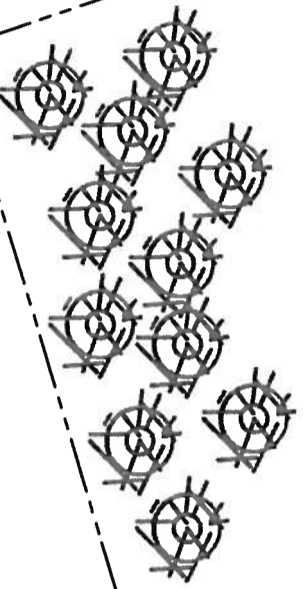
LOT 13 R/W TRACT 9

32' WIDE PUBLIC ACCESS & UTILITY RIGHT OF WAY

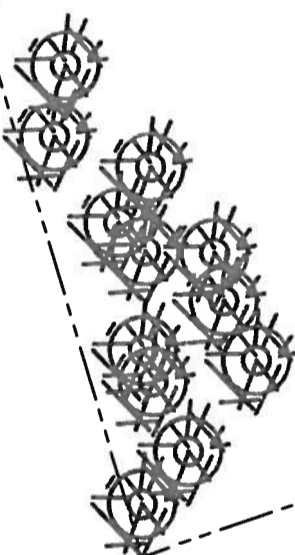

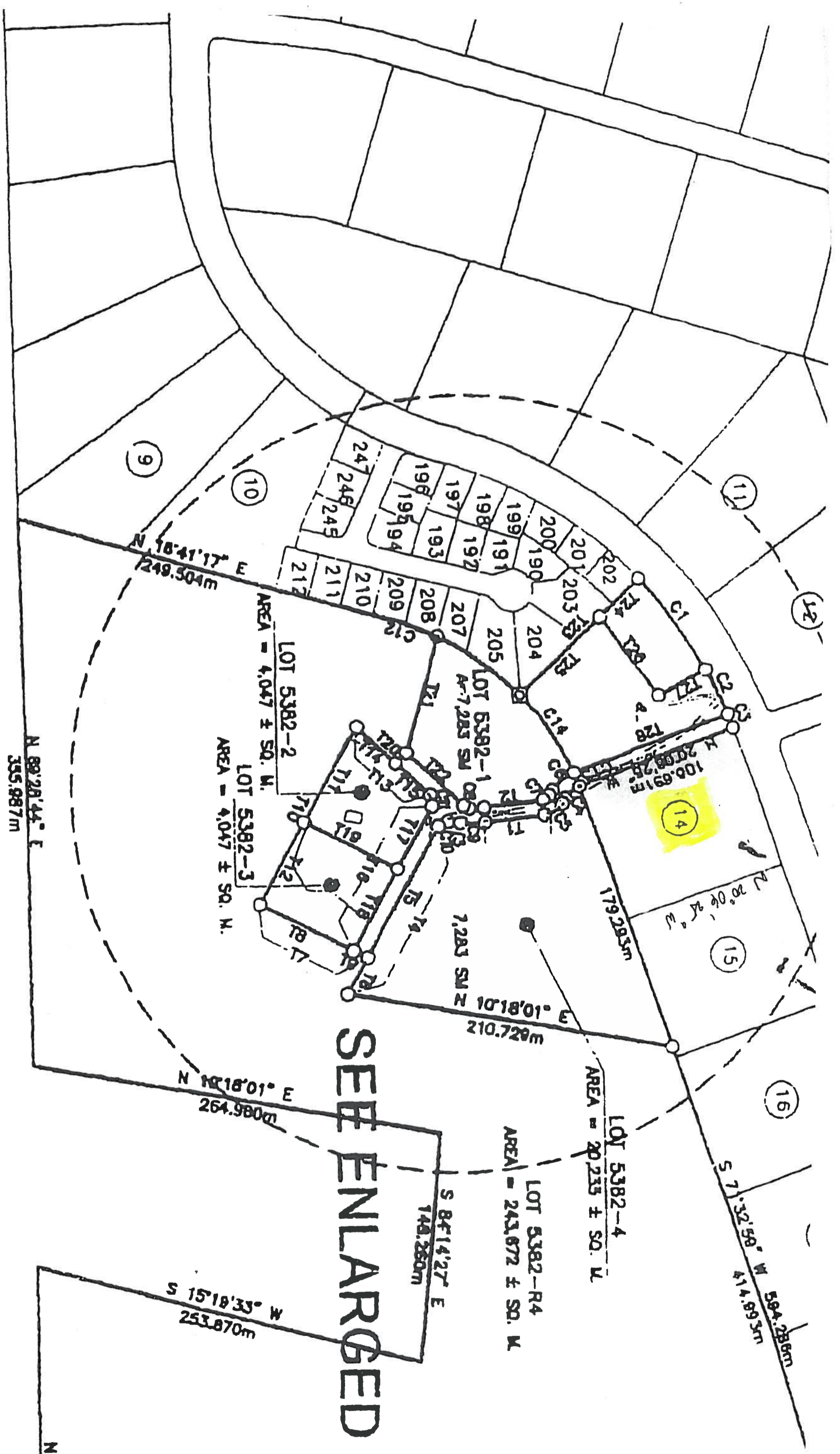


LOT NO. 15, BLK "F"
