**The AOR is a 2.9-acre parcel located along "Stream 1". The AOR commences approximately 0.07 miles north-northwest of the intersection of Kamalani Street and Mamalohoa Highway in Kona on the Island of Hawai'i, Hawai'i. The AOR is**

outlined in red in Enclosure 1. The AOR has one potential water onsite which is the subject of this analysis. The one potential water was identified as an approximately 0.53 miles feet of “Stream 1” (19.648971°, -155.950538°)

A variety of sources were reviewed for “Stream 1” on the AOR and are described as follows:

The hydrologic unit code for the AOR is 200100.

The NRCS Soil Survey indicated that the AOR contained the following soil series: Honuaulu-Kealakekua Complex (10 to 20% well-drained, non-hydric) and Honuaulu Hydrous Silt Loam (10 to 20 % slopes, well-drained, non-hydric).

“Stream 1” within the AOR is oriented immediately in the center of the AOR. Aerial imagery was reviewed during a rain event period (see below) and no observation of flow was present. “Stream 1” is present on the 2017 USGS Kailua topographic quadrangle layer for Google Earth Pro within the AOR. The terrain data layer for Google Earth Pro indicates that “Stream 1” has a general topographic gradient to the west-southwest, towards the Pacific Ocean (a TNW).

“Stream 1” is shown on 2017 USGS Kailua Quadrangle topographic map data layer for Google Earth Pro as an intermittent stream.

The following aerial images from Google Earth were observed for the AOR: OCT 2003, JAN 2013, MAY 2018, and JUN 2019. No dark signatures indicative of surface waters were observed in aerial imagery on the AOR. Inundation observed on aerial imagery is a primary indicator of hydrology. Hydrology was absent on the imagery.

As shown in USFWS National Wetlands Inventory data layer for Google Earth Pro, “Stream 1” flows west-southwest to the Pacific Ocean through the AOR. The westernmost boundary of the AOR is approximately 2.6 miles upgradient of the Pacific Ocean. The NWI describes the stream as riverine, intermittent, streambed that is seasonally flooded. Aerial imagery was reviewed during a two-inch rain event period (see below) and no observation of hydrological flow was present. The terrain data layer for Google Earth Pro indicates that “Stream 1” has a general topographic gradient to the southwest, towards the Pacific Ocean.

The USGS National Water Information System (online access) did not exhibit a stream gauge on “Stream 1” on the AOR. The nearest stream gauge is in the Waiaha Stream (0.55 miles south of the intersection of Water Pipe Road and Mamalahoa Highway), approximately 1.05 miles south of the AOR.

According to the Weather Underground’s weather history for the Lanihau 1 & 2 Ahupua’a Stations (both located approximately 0.08 miles south of the AOR), the AOR received approximately two inches of rain on 14 MAR 2021. Digital Globe aerial imagery, dated 12 and 19 MAR 2021, was used to observe the pre-rainfall conditions and the potential water runoff conditions from that rain event on the AOR. There was no water observed in “Stream 1” before or after that rain event on the selected Digital Globe aerial imagery. This information is significant because a two-inch rainfall is generally 5% of the amount of annual rainfall that the AOR receives. The Rainfall Atlas of Hawaii (maintained by the University of Hawaii) depicts a discontinued station named “Keopu Mcwayne” (located at 19.645°N, -155.967°W) located approximately 0.89 mile west-southwest of the western end of the AOR. Data for this station was collected from 1958 to 1978. The average annual rainfall for this station was listed as 41.67 inches. The closest (approximately 1.4 miles south) current station to the AOR is named “Waiaha Stream” (located at 19.630°N, -155.940°W) in an adjacent watershed to the AOR. Data for this station has been collected from 1991 to present. The elevation of the gauge is 1,511 feet, which is approximately within the elevation of the AOR, which is between approximately 1,450 feet (on the western end of the AOR) to 1,900 feet above sea level (on the eastern end of the AOR). The average rainfall for this station was listed as 48.24 inches.

In accordance with 33 CFR 328, based on the information above, the Corps has determined that “Stream 1” is not: 1) currently used, nor was used in the past for interstate or foreign commerce, including waters which are subject to the ebb and flow of the tide, 2) an interstate water or wetland, 3) an intrastate lake, river, stream (including intermittent streams), mudflat, sandflat, wetland, slough, prairie pothole, wet meadow, playa lake, or natural pond, 4) an impoundment of Waters of the U.S., 5) a tributary of Waters of the U.S., 6) a territorial sea, 7) a wetland adjacent to Waters of the U.S., or 8) prior converted cropland. “Stream 1” does not have a significant nexus to a RPW or TNW. The Corps has determined that “Stream 1” is an ephemeral feature.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
