- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: A site visit was conducted to determine if waters of the United States are present on the area where a single family home development is proposed on approximately 2 acres of land. The site visit was conducted on November 18, 2020 at 1330 immediately following a brief rain shower. The vegetation at the sampling point was representative of the site overall with an asphalt walkway grid present shown in aerial photos. The site had little to no change in slope. The data collected, as shown on the wetland determination form, confirmed there is no evidence hydrology, hydrophytic vegetation, or hydric soils. In conclusion, the Corps determination of the Rinehart Estate Single Family Home site is that it consists solely of dry land and does not contain wetlands, streams, or other waters regulated by the Corps.
