C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The proposed activities would involve repairs on irrigation ditches (‘auwai) at the Honopou, Keanae, Wailuanui, and Nahiku sites that may involve the discharge of fill. The ditches at all four locations were originally constructed in uplands and convey water from a stream channel to ongoing active agricultural operations in uplands without any discrete or confined flow returning to a stream channel. Since the irrigation ditches do not have return flow into streams that lead directly or indirectly into waters of the U.S., the irrigation ditches are non-jurisdictional waters.
