- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Fujita Pond is a constructed infiltration basin with no defined outlet structure. It receives runoff via a series of stormwater conveyance systems from an approximately 180 acre area located west of Marine Corps Drive and north of Fujita Road. This area is drained by a triple box culvert trunk line running under San Vitores Road that outlets into Fujita Pond. The overtopping elevation of Fujita Pond is approximately 1 foot higher than the low elevation on San Vitores Road, and flooding is controlled by the water level in Fujita Pond. Flooding typically occurs in the low area of San Vitores Road following rainfall events greater than 3.5 inches in a day. The flood events tend to occur on the order of one to three times per year during normal precipitation patterns. Fujita Pond was originally constructed as an infiltration basin that was designed to receive runoff conveyed to it via the box culvert system under San Vitores Road. The pond was constructed in upland outside of any natural drainages or ponding areas. Based on the surrounding topography, the pond area is not in a natural low spot; it outflows towards the north and collects on Fujita Road. The intent of the San Vitores Road Flood Mitigation Project is to maintain water levels in Fujita Pond below the low point of San Vitores Road for the modeled rainfall events, in order to avoid flooding issues on the road and in the surrounding area. .**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Fujita Pond is a man-made pond strictly dug out of uplands for stormwater collection purposes with no connection to jurisdictional waters of the US. The NWI map does not map this pond with any wetland/waters indicator. The 1988 Soil Survey indicates the pond is located in Shioya Loamy Sand, which is an excessively drained soil series and/or in Guam-Urban land complex, which is a limestone complex, hosts urban development, is a well-drained cobbly clay complex with moderatley

rapid permeability. There is no evidence that this area was ever part of a historic stream, marine water or wetland and there is no evidence of any connection to adjacent marine waters. The USGS NHD data designates this pond as a reservoir with a short artificial path flow direction into the adjacent wooded parcel. Therefore, this information along with that presented in Section I(B)(2) supports the decision that Fujita Pond is not a jurisdictional water of the US. .
