- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: A jurisdictional determination request was received on August 3, 2016 for three (3) man-made features located on the Chevron Hawaii Refinery (Refinery) property in Kapolei, Island of Oahu, Hawaii (Tax Map Key (1) 9-1-014:010). The three man-made ponds under review include: Rowland's Pond (6-acres), a 1-acre pond, and ¼-acre pond, all of which are located adjacent to each other within the 249 acre Refinery boundaries of the James Campbell Industrial Park.

Rowland's Pond is 6-acres in size, located approximately 0.38 miles from the Pacific Ocean (the nearest traditional navigable water), and was constructed to contain stormwater runoff or releases of petroleum. Starting in 1989, Rowland's Pond was used as a containment area of non-hazardous sludge once every three years. Between 2005-2012, this pond was managed to provide safe nesting and foraging habitat for two endangered species: the Hawaiian Coot (*Fulica americana alai*) and the Hawaiian Stilt (*Himantopus mexicanus knudseni*). Since 2012, the pond has been covered to prevent nesting and foraging and is typically dry and devoid of vegetation. The elevation of the bottom of the pond was estimated from 1-2 meters above mean sea level (MSL). Water may periodically collect in the pond following heavy rainfall events, but quickly dissipates. The pond was observed during high tide over five days between May 16 and 20, 2016. No water was observed in the pond, confirming the pond is not tidally influenced.

The 1-Acre and 1/4-Acre Ponds are located adjacent to Rowland's Pond. The 1-Acre and 1/4-Acre Ponds formerly received tank water draws, but are no longer in use. The 1-Acre Pond is located 0.52-miles from the ocean, the nearest traditional navigable water. The elevation at the bottom of the 1-Acre Pond ranges from 0.3 to 0.6 meters above MSL. The 1/4-Acre Pond is located 0.51-miles from the ocean, the nearest traditional navigable water. The elevation at the bottom of the Yi-Acre Pond ranges from 0.8 to 0.9 meters above MSL. The 1-Acre and 1/4-Acre Ponds are man-made features. Water may periodically collect in the ponds following heavy rainfall events, but quickly dissipates. The ponds were observed at high tide over five days between May 16 and 20, 2016. No water was observed in the ponds, confirming they are not tidally influenced.

The USFWS National Wetlands Inventory (NWI) map identified the three ponds as freshwater ponds (PUSC_x: Palustrine (P) Unconsolidated Shore (US) Seasonally Flooded (C) Excavated (x)). The National Hydrography Dataset (NHD) does not map any surface connections between these ponds and the Pacific Ocean. The three ponds have been determined to be non-tidal man-made features that are typically dry. The Corps does not typically consider the artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are exclusively for such purposes as stock watering, irrigation, settling basins or rice growing to be waters of the U.S. (1986 Preamble). Therefore, these ponds would not be considered Waters of the U.S. as defined in Section 404 of the Clean Water Act, under the jurisdiction of the Army Corps of Engineers

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION: N/A

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

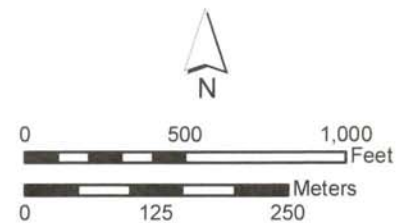


Figure 1
